WHEREAS: Such exercises could present hazards to life and property of participants, observers or attendees;

NOW THEREFORE: In consideration of being afforded the opportunity to observe, attend or participate in such firefighters muster game exercises;

1. I acknowledge the inherent dangers of such exercise and assume the risk to my person and property, both personal and that of others under my control and supervision.
2. I agree to hold harmless and waive all claims arising from my participation, observation or attendance of said exercise for damages to myself, my property or property of others under my control and supervision arising out of the action or inaction, through any negligence or otherwise other than deliberate and intentional tortuous action by the Vermont State Firefighters Association, its agents and employees in both their official and personal capacities.
3. Further, this Waiver of Liability and agreement to hold harmless extends to all claims that might devolve to the benefit of my heirs, assignees, administrators or executors, including, but not limited to, all claims arising from my wrongful death.
4. Further, the protection of the Waiver of Liability and agreement to hold harmless extends to all co-operating organizations, corporations and individuals, their agents and employees, in both official and personal capacities, who are assisting the Vermont State Firefighters Association in the preparation and conduct of these mentioned exercises.
